### GENERAL TERMS OF CAR & BIKE SHOW PARTICIPATION AGREEMENT

1. The vehicle owner shall be responsible for set-up and removal of their own equipment, fixtures, and other property. Electricity will NOT be provided.
2. The vehicle owners should have adequate protection for inclement weather, the sun and heat. Bring appropriate coverage. If the weather becomes too inclement to operate, The City of Vincent will be responsible for making final determination of outdoor operations.
3. No alcohol, No disruptive music, No burnouts on show property.
4. Vehicle owner agrees to indemnify and hold harmless the City of Vincent, its officers, directors, representatives, employees, and agents for all penalties, fines, costs, expenses, damages, from the participating vehicle owners' failure to comply with such laws.
9. The vehicle owner shall maintain allocated space in a neat, safe, and orderly condition during the event.
10. At the conclusion, the vehicle owner must remove garbage, and equipment from the allocated space.
11. The vehicle owner agrees that THE CITY OF VINCENT, its officers, directors, representatives, employees, and agents shall have no responsibility whatsoever for any loss or damage to the vehicle owners equipment, supplies, goods, or other property.
12. The vehicle owner agrees to indemnify and hold harmless representatives, employees, and agents of the festival and/or the City of Vincent against all claims of any person whomsoever, from acts or omissions of the vehicle owner, its representatives, employees, agents, patrons, or guests.
