

ORDINANCE NO. 2011 – 001

AN ORDINANCE OF THE TOWN OF VINCENT, ALABAMA, ESTABLISHING A FEE TO OFF-SET THE COST OF HOUSING PRISONERS IN THE COUNTY JAIL, AND MEDICAL EXPENSES INCURRED BY PRISONERS WHILE INCARCERATED IN THE COUNTY JAIL:

BE IT HEREBY ORDAINED by the Town Council of the Town of Vincent, Alabama, has determined that the housing and medical expenses of prisoners in the county jail is causing the Town a financial burden and;


WHEREAS, the Shelby County Jail charges a fee to the Town of Vincent for each inmate housed, plus all medical expenses incurred while the prisoner is incarcerated in the county jail;


BE IT FURTHER RESOLVED, that the Court Clerk/Magistrate shall add these charges to the fine and cost the prisoner is being charged with.




THIS ORDINANCE is enacted in good faith for the public interest, and shall take effect immediately upon adoption and publication as required by law.






